**Commitment to the legal use, retention and sharing of information (in line with the Privacy Act)**

Please note that the information asked for in this form is to meet the requirements of the school and Ministry of Education.

Address and phone number details are collected at the time of enrolment and during the student’s time at school so that the school can contact the parent or student as necessary. When a student leaves school these contact details may also be passed to the Ministry of Social Development (MSD) by the Ministry of Education via ENROL and roll returns. This is so young people who may have difficulty finding future employment, training or further education can be identified and offered support by organisations contracted by MSD to help re-engage young people in education or training when they leave school.

Names, addresses and telephone numbers will be made available to BOT, teachers and/or staff. From time to time names, addresses and telephone numbers may also be given to INFUSE for the purposes of contacting parents on school related matters.

All information contained in this form will be treated as personal. It will be entered into the school Administration computers and password protected. The form will be kept in a locked file. On the student leaving to attend another school we will forward school records of the student to that school when requested by the next school. In the case of a student leaving school to take up employment the records are kept on file for seven years. In the case of a family deciding to home school the files are kept at the school for seven years but copies are available for the parents.

Please note that at any time you may request access to information and you may request correction of that information. Requests should be made in writing to the Principal or Office Manager.
